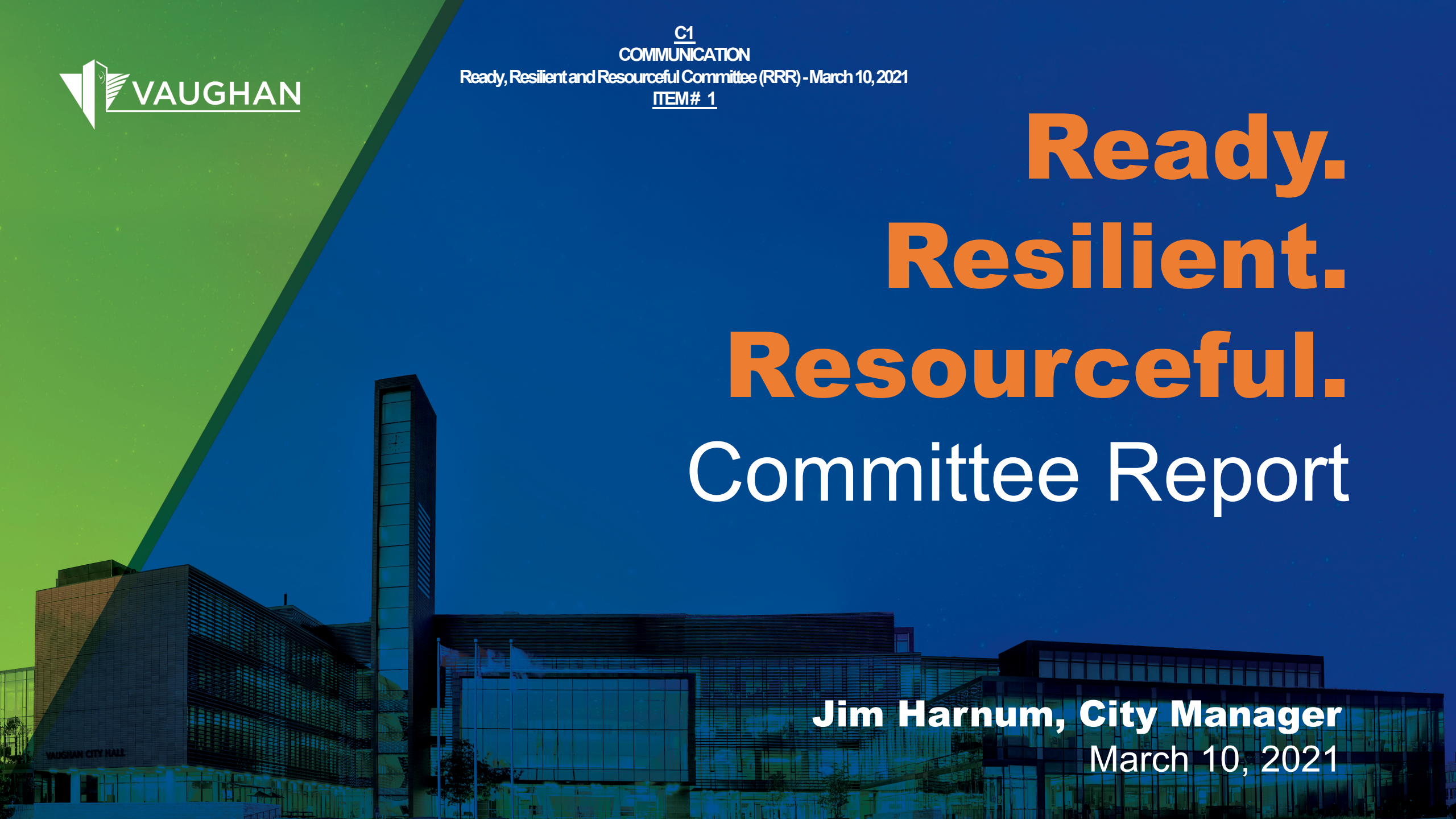

# Orders and Enforcement

- **March 17, 2020**  
Mayor's declaration – State of Emergency, BCLPS mobilized.
- **March 18, 2020**  
BCLPS/Enforcement established; continues to lead Regional Enforcement Task Force.
- **April 2020**  
Council adopts the first Emergency Measures By-law.

## Enforcement Activity March 2020 to present:

### 40,514 total case files

- 20,015 COVID related cases
  - 9,499 non-COVID cases
  - 11,000 Animal Services cases
  - 4,100 Cautions
  - 192 Charges
- 
- Region wide: 44,889 cases (approx. 48% of the total COVID enforcement activity region wide).






# Orders and Enforcement

---

- BCLPS remained at the forefront of the fight against the spread of COVID-19 through public visibility, education and enforcement.
- Strategic approach: progression through the enforcement continuum:
  - education; escalation to caution; escalation to direct enforcement (charges).
- Businesses supported through various initiatives:
  - Open for Business, enhanced online services, online AMPs disputes, temporary patio by-laws, additional relief initiatives for small business pending Council's approval).
- Red Control Zone:
  - support re-openings
  - recovery through allowing for restricted business operations (limited in-store dining, allowances for small gatherings, etc.).
  - multi-jurisdictional joint initiatives focused on big box stores, eating establishments, personal services and fitness centres.

## ROLES AND RESPONSIBILITIES



- Support hospitals in operation of vaccine clinics
- Provide overall vaccination program support and administer vaccines to residents, health-care workers and essential caregivers within long-term care, retirement homes and congregate living settings for seniors in the early stages of Phase One of Ontario's vaccine distribution plan
- Vaccine storage and Regional distribution
- Liaison between Ministry of Health and hospitals
- Liaison between Ontario Health and long-term care homes, retirement homes and congregate living settings
- Implement mass immunization clinics to administer vaccines to priority groups in subsequent phases of the vaccine distribution plan

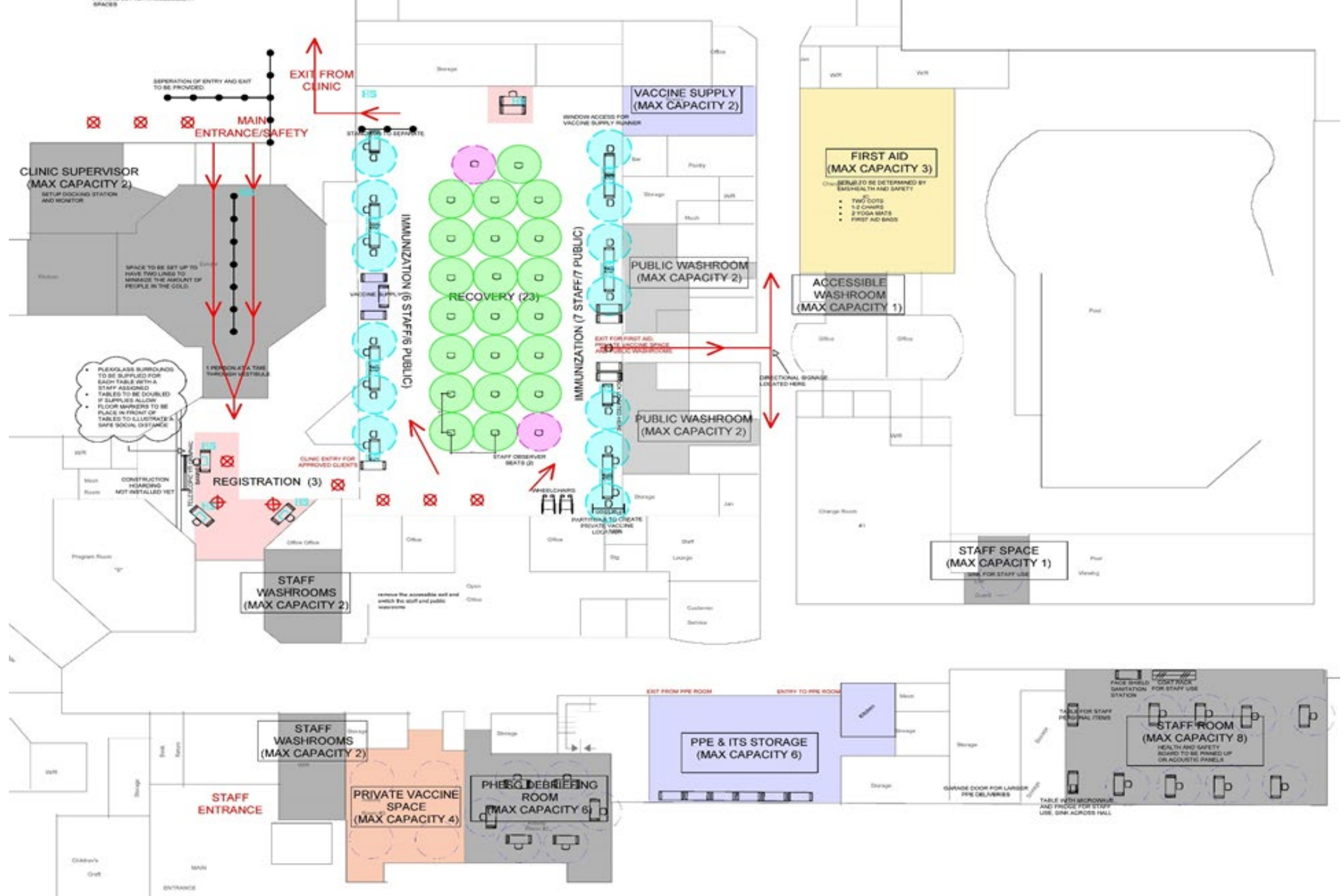

# Vaccination Clinic Locations in Vaughan

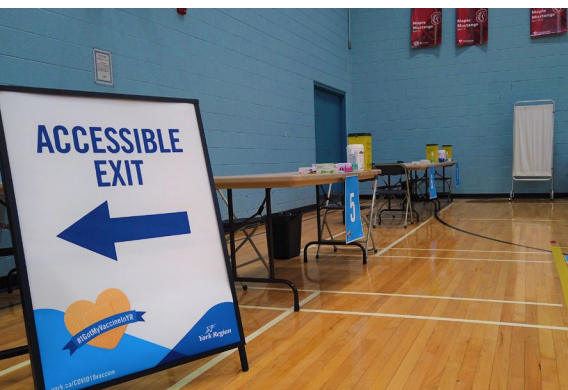

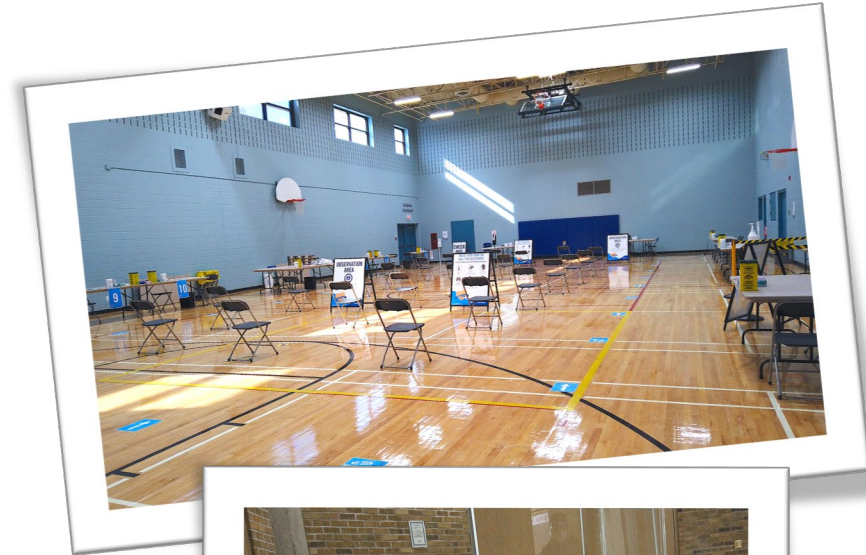
