**Minor Variance Application A148/20 Ward 5**

**Purpose:**

**Relief from By-law 1-88, as amended, is being requested to permit the construction of a proposed one story addition at the rear of the dwelling. The addition is to function as a glass enclosure around the existing pool.**

We respectfully request this Minor Variance be declined for the following reasons:

- The proposed detached structure would set a new precedence for large scale construction in the neighbourhood
- In defiance of city regulations, construction on the proposed detached structure has commenced without necessary permits
- The proposed detached structure size (spacing, height and materials) exceeds allowed variances as per municipal law
- The proposed detached structure would act as an addition to the existing dwelling
- No shadow study or perspective drawings from neighbouring properties have been produced
- The proposed detached structure would negatively impact surrounding neighbourhood property values
- The proposed detached structure would compromise the integrity of neighbourhood green space and damage the overall character of the neighbourhood
