BY-LAW

BY-LAW NUMBER 111-2021

A By-law to dedicate certain lands as part of the public highway.

WHEREAS Section 31 of the Municipal Act, 2001, S.O. 2001, c.25 confers that land may only become a highway by virtue of a by-law establishing the highway and not by the activities of the municipality or any other person in relation to the land.

NOW THEREFORE the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

1. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Blocks 117, 119, 124, 129, 132 and 136 on Plan 65M-4360 and Block 166 on Plan 65M-4561, registered in the Land Registry Office for the Land Titles Division of York Region (No.65), be and they are hereby dedicated as part of public highway known as “Stormont Trail”.
2. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Blocks 121 and 122 on Plan 65M-4360, registered in the Land Registry Office for the Land Titles Division of York Region (No.65), be and they are hereby dedicated as part of public highway known as “Madoc Place”.
3. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Blocks 126 and 127 on Plan 65M-4360, registered in the Land Registry Office for the Land Titles Division of York Region (No.65), be and they are hereby dedicated as part of public highway known as “Gallant Place”.
4. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Block 152 on Plan 65M-4561, registered in the Land Registry Office for the Land Titles Division of York Region (No.65), be and they are hereby dedicated as part of public highway known as “Carling Road”.

5. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Block 153 on Plan 65M-4561, registered in the Land Registry Office for the Land Titles Division of York Region (No.65), be and they are hereby dedicated as part of public highway known as “Cannes Avenue”.

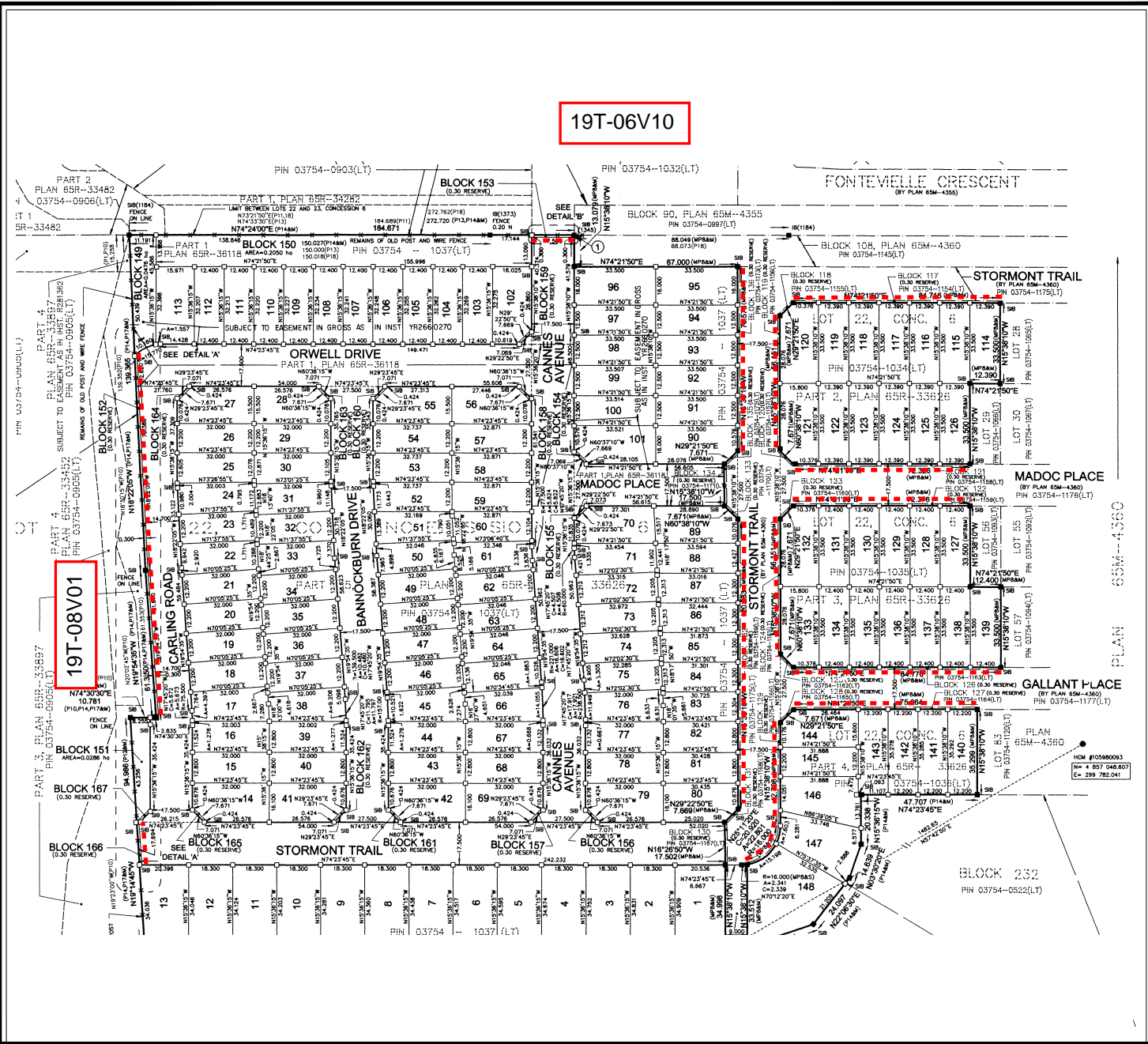
