To Whom It May Concern,

My husband and I are writing you today to advise that we are 100% opposed to Official Plan Amendment file OP.21.015, Zoning By-law amendment file Z.21.026. This area is a subdivision of houses, we and our neighbours do not want a 14 storey condominium built in front of our homes obstructing the sunshine of the houses located behind it. Our neighbourhood already has a building on 4800 Highway 7 and Benjamin Drive. The prices of the homes across from this development have already sustained a substantial loss in market value, and we do not want the same to happen to the homes in our neighbourhood.

Please understand we are not opposed to the development of Vaughan, but there has to be a limit and some consideration for the current residents. We have witnessed all the developments along Highway 7, along Rutherford Road, and along Islington Avenue, but all these developments do not have subdivisions beside or behind them. They are not spoiling views, obstructing sunlight or decreasing market values of the surrounding subdivisions as the development above would undoubtedly do.

There are so many locations along Highway 7 where the City could build a 20 storey building without damaging the existing residents' (current property tax payers) property value. We are so concerned about this proposed development that many of us are considering leaving Vaughan. When we bought our homes here, we purchased in a single home family subdivision and there were no plans for multiple dwelling construction in the proposed development of the area.

We are respectfully requesting that you adhere to the original development plan for this area and please stop this project in this location. My Place on 7 Inc. can consider building townhouses in this area, but please no high rise multi dwelling building. We hope elected Council members and staff of the municipality will be working to protect our interests instead of those of big business corporations who are only interested in making money and have no consideration for the lives they will be impacting.
