Vaughan Mayor and members of Council;

It is alarming that some Municipalities feel they are entitled to circumvent the requirement for reasonable notice on agenda items. Caledon and Vaughan are frequently posting items relating to the GTA West Corridor/Highway 413 without adequate notice which is severely limiting the ability of the public to be involved or respond.

Vaughan Mayor and Members of Council,

Respectfully, I ask that the Item 9.3 Consideration of The Transportation Taskforce's Meeting Minutes be deferred until November 9th as was originally communicated in the below email from the City Clerk on October 8th.

The community has been preparing and planning to send letters and give deputations in one week's time, not tomorrow. We have discovered after the deadline to submit communication or deputations requests that the meeting minutes are on tomorrow's Nov. 2nd agenda. This has effectively curtailed any opportunity for public input, whether intentional or not.

It is alarming, and quite frankly disheartening, that the Clerk and City Manager, who approve the agenda, saw no issue with changing the date after sending this email. A different date had clearly been communicated to the public

and media almost a month early. They have made no attempt to notify anyone that the meeting minutes have been brought forward earlier. On top of this there are significant procedural concerns that occurred at the Oct 7 Transportation Taskforce meeting.

- How did the motion to support the EA contrary to a previous Council decision which supported the Federal Impact Assessment end up being voted on after the Chair left the meeting?
- The meeting is not recorded so there is no why for the public to now other than to ask members who were present.
- Were conflicts of interest declared properly? The MTO and Metrolinx staff members do not appear to have declared a conflict of interest? Jullian Britto appears to or has worked for WSP and the Town of Caledon; she did not declare a conflict of interest?
- If these are conflicts and they were declared would the motion have passed?

This is the third occurrence since September in which agenda items relating to the GTA West Corridor/Highway 413 have been brought forward in a manner that reduces transparency, notice and the ability of the public to be involved if they so choose.

- 1. Sept 10, 2021 a staff communication <u>SC.3</u> provided an update on the GTA West Corridor was not listed as a line item. One would only have known it was present if they clicked and reviewed all staff communications.
- 2. The <u>Transportation Taskforce Meeting</u> had a presentation given from the GTA West Team with no notice provided to the public and somehow a motion to support the Province's ongoing EA was voted upon and supported, after the Chair left the meeting and it would appear members with conflicts of interest voted upon said motion and did not declare real or potential conflicts.
- 3. The meetings of the <u>Transportation Taskforce</u> have been brought forward one week ahead of what had been communicated to members of the public and media.

I hope that in the interest of good governance at the City of Vaughan, a strategic goal of this Council term that this item will be deferred and allow the public the opportunity to comment on the proposed motion or that the procedural irregularities will be investigated and the motion of support for the GTA West EA withdrawn.

I thought it may also be of interest to Vaughan Council to know that the Town of Caledon recently made a blatant attempt to <u>support the GTA West Corridor/Highway 413 and to undermine the Region of Peel's</u> withdrawal of support. In so doing they were not compliant with their own procedural by-law, the municipal act and many other concerning items arose from this meeting that are still unraveling.

Mr. Coles,

I regret that I am sending you another email about process and procedural matters at the City of Vaughan. It is not

my intent to be vexations or frivolous. Nor is it my intent to portray staff or Council in any negative manner. Unfortunately, as of late the role between government and governance seems continually blurred. Asking these questions, I believe, is necessary to ensure that these roles and distinctions are upheld.

As I started to prepare for next week's Official Plan meeting I came across <u>today's Transportation Taskforce</u> <u>Meeting</u> which included a presentation from the GTA West Project Team. I have the following questions.

What is the procedure for presentations for a taskforce? Did the Committee request the presentation, if so is this documented in previous meeting minutes? Was it a request of the GTA West Project Team, if so would this be subject to Vaughan's Procedural By-Law and was a presentation request submitted?

Can you please confirm the Transportation Taskforce Committee Members (council and members of the public) and who was present for today's meeting?

Can you please confirm what date the agenda was posted with the GTA West Presentation Item listed, as well as the date the Communications link was posted, which includes the <u>presentation</u>?

#### 3. NEW BUSINESS – ATTENDANCE AT TASK FORCE AND SUB-COMMITTEES MEETINGS

The Transportation and Infrastructure Task Force advises Council:

Due to the lack of attendance at the Task Force and Sub-Committees meetings, Councillor DeFrancesca, Chair of the Transportation and Infrastructure requested that an email be sent out to all members to reaffirm their commitment to the Task Force mandate, including attending all meetings on a regular basis.

The foregoing matter was brought to the attention of the Task Force by Councillor DeFrancesca.

I find it very concerning that the GTA West Team has been provided an opportunity to present to the Transportation Taskforce when membership appears to be in flux, the Chair was absent and it is unclear what prompted the GTA West Team presentation. It is also unclear if members of the public were notified in any way that this presentation would be occurring. Given the high level of public concern and media attention the GTA West Corridor has received combined with continued complaints from residents about the lack of meaningful public consultation I find it unsettling that the City of Vaughan and/or Councillors aware did not believe it was necessary to increase public awareness of this agenda item. I would've thought it would be in the best interests of Vaughan to do so to demonstrate a commitment to public awareness/involvement, transparency and accountability in government and governance at the City of Vaughan. Finding it like this would make it appear that the City of Vaughan and the GTA West Team are strategizing to find a way to have Highway 413 return to Vaughan Council's agenda *in an effort to overturn the Vaughan Council decision made on March 10, 2021 that resulted in the City of Vaughan 413/GTA West Corridor.* 

This sentiment is only compounded by the <u>staff communication dated Friday Sept 10, 2021 providing an update on</u> <u>the GTA West Corridor</u> on the Committee of the Whole's agenda Tuesday September 14, 2021. It seems likely that it was only posted for one full business day. Because this item was not a staff report it was buried within the staff communications, it was not a line item on the agenda and therefore easily missed by the public. I never received an answer to my question submitted in my communication to this meeting. What is the difference between a staff communication and staff report? In the past updates on the GTA West Corridor were provided as staff reports.

Weston Consulting is the planning consultant for Genazzano Highrises Inc., Granerola Residences Ltd., and Dulcina Investments Inc. the registered owner of the lands at 9000 Jane Street, 8960 Jane Street and 27 Korda Gate, in the City of Vaughan (herein referred to as the "subject lands"). We have reviewed the Vaughan Mills Centre Public Realm + Streetscape Master Plan, final report, dated November 2021, that was considered and approved by City of Vaughan Committee of the Whole on November 3, 2021. We are pleased to provide the enclosed comments on behalf of the owner and request that this letter be considered at the City of Vaughan Council Meeting on November 16, 2021.

#### Status of Planning Applications on the Subject Lands and Secondary Plan Participation

Several years of mediation at the Ontario Land Tribunal (formerly the Ontario Municipal Board) have led to decisions rendered on Official Plan Amendment and Zoning By-law Amendment Applications for the subject lands. Following this decision, the landowner submitted Site Development Applications, DA.18.047, DA.19.084 and DA.20.060, to facilitate the development of the master planned community known as 'Charisma'. The above-noted planning applications have been approved and agreements either executed or underway for the development of the subject lands.

The landowner has been monitoring and an active participant in the Vaughan Mills Centre Public Realm and Streetscape Master Plan and over the years has been an active landowner within the Vaughan Mills Centre Secondary Plan Study Area, including online meetings on October 22, 2020 and February 23, 2021, where the Master Plan was discussed.

#### Review of and Comment on the Vaughan Mills Centre Master Plan

Weston Consulting and the landowner have reviewed the Vaughan Mills Centre Public Realm + Streetscape Master Plan, dated November 2021. We offer the following comments based on our review of the draft Vaughan Mills Public Realm and Streetscape Master Plan:

#### 1. Current and Future Traffic Demands and Fishermens Way

We have concern with the planned 2-lane road design of Fishermens Way. The landowner does not agree with the principle of the 2-lane road construction and the reduction from 4-lanes, which was contemplated by the City of Vaughan at the planning application stage for the site-specific development applications, and as contemplated in development agreements between the City and the landowner.

It is our understanding that the Secondary Plan has planned for Fishermens Way to be a future *Minor Collector* street, and that Volume 1 of the City of Vaughan Official Plan identifies minor collector streets as "generally [having] a maximum of two travel lanes and projected traffic volumes shall be less than 500 vehicles in the peak hour and 5,000 vehicles per day". Based on our review of the November 2021 Final Master Plan Report, we understand that a Tertiary Plan process is anticipated for the phased future development of the Vaughan Mills Mall lands, whereby further transportation, detailed design and analysis would be undertaken to determine the contemplated 3-lane variant option as outlined in the Master Plan.

Based on the technical work and consultation completed to-date through our client's sitespecific application process, we request that the City of Vaughan implement Fishermens Way as a 4-lane road, as previously planned. The reduction of the road to two lanes is inappropriate and premature given that the Mall is a destination and that the Mall's owners have not advanced preliminary plans and studies to the City of Vaughan through a Tertiary Plan process or formal planning applications.

It is our anticipation that without formal planning applications or commencement of a Tertiary Plan there is limited understanding of the level of development and subsequent servicing levels demanded by any future development of the Mall lands. As identified in the Master Plan, the detailed design of Fishermen's Way is "subject to a Future Tertiary Plan for Vaughan Mills Mall"; therefore, the categorization of the roadway as a 2-lane street instead of 4-lanes is premature and not supported by sufficient study.

#### 2. Land Ownership and Development Agreement

We request that the City of Vaughan provide supplementary information on how Fishermens Way will function in relation to our client's lands. The Master Plan does not confirm if any of the proposed boulevard treatments for Fishermens Way would be located on our client's lands, and how the existing underground servicing and utility easements that run along the outer edge of the ring road will be dealt with in an ultimate condition, following the dedication of lands to the City as part of the site-specific planning applications and the construction of Fishermens Way.

It is acknowledged that as part of the existing development agreements between the City of Vaughan and the landowner, portions of land will be dedicated for the future construction

of Fishermens Way. It is also acknowledged that the City of Vaughan has contemplated "enhanced streetscaping" as part of the Master Plan and the ultimate condition of Fishermens Way. We request that the City of Vaughan identify the level of obligation that the landowner is required to fulfil as part of proposed streetscape enhancements along Fishermens Way. Should the landowner be required to implement enhanced streetscape conditions for Fishermens Way as part of the fulfilment of application conditions, it is our request that the improvements be considered as Section 37 contributions and discounted towards financial requirements for the approved development.

It is acknowledged that the Vaughan Mills Centre Secondary Plan and Public Realm and Streetscape Master Plan are "living documents", and that review and update of the Plans is appropriate under the *Planning Act*, however, the Master Plan should acknowledge the planning process and approvals, and the conditions that were discussed and approved by the City and the landowner, as they relate to the Secondary Plan Area and the Plan's ultimate public realm and streetscape conditions.

We reserve the right to provide further comments as part of the ongoing Vaughan Mills Centre Public Realm and Streetscape Master Plan and any future update to the Vaughan Mills Centre Secondary Plan. We request that this letter be added to the public record for the City Council Meeting on November 16, 2021 and request to be notified of any future reports and/or meetings and decisions regarding this matter.

# Status of Planning Applications on the Subject Lands and Secondary Plan Participation

Several years of mediation at the Ontario Land Tribunal (formerly the Ontario Municipal Board) have led to decisions rendered on the Official Plan Amendment and Zoning By-law Amendment Applications for the subject lands (OLT Case Numbers: PL110419, PL110420, PL110455, PL11456, PL140839, PL111184). Minutes of Settlement between the owners, the City of Vaughan and Regional Municipality of York were executed on June 20, 2018, whereby a series development conditions obligating the owner of the lands to dedicate portions of the subject lands for implementation of public realm and streetscape infrastructure was outlined. As a requirement of the approvals and the Minutes of Settlement, the landowner is in the process of entering into an agreement with the City of Vaughan for development servicing and for the extension of Romina Drive.

The landowner has been monitoring the Vaughan Mills Centre Public Realm and Streetscape Master Plan and over the years has been an active landowner within the Vaughan Mills Centre Secondary Plan Study Area.

It is our understanding that the Secondary Plan has planned for Fishermens Way to be a future *Minor Collector* street, and that Volume 1 of the City of Vaughan Official Plan identifies minor collector streets as "generally [having] a maximum of two travel lanes and projected traffic volumes shall be less than 500 vehicles in the peak hour and 5,000 vehicles per day". Based on our review of the November 2021 Final Master Plan Report, we understand that a Tertiary Plan process is anticipated for the phased future development of the Vaughan Mills Mall lands, whereby further transportation, detailed design and analysis would be undertaken to determine the contemplated 3-lane variant option as outlined in the Master Plan.

Based on the technical work and consultation completed to-date through our client's sitespecific application process, we request that the City of Vaughan implement Fishermens Way as a 4-lane road, as previously planned. The reduction of the road to two lanes is inappropriate and premature given that the Mall is a destination and that the Mall owners have not advanced preliminary plans and studies to the City of Vaughan through a Tertiary Plan process or formal planning applications.

It is our anticipation that without formal planning applications or commencement of a Tertiary Plan there is limited understanding of the level of development and subsequent servicing levels demanded by any future development of the Mall lands. As identified in the Master Plan, the detailed design of Fishermen's Way is "subject to a Future Tertiary Plan for Vaughan Mills Mall"; therefore, the categorization of the roadway as a 2-lane street instead of 4-lanes is premature and not supported by sufficient study.

#### 2. Land Ownership and Development Agreement

We request that the City of Vaughan provide supplementary information on how Fishermens Way will function in relation to our client's lands. The Master Plan does not confirm if any of the proposed boulevard treatments for Fishermens Way would be located on our client's lands, and how the existing underground servicing and utility easements that run along the outer edge of the ring road will be dealt with in an ultimate condition, following the dedication of lands to the City as part of the site-specific planning applications and the construction of Fishermens Way.

It is acknowledged that as part of the future development agreements between the City of Vaughan and the landowner, portions of land will be dedicated for the future construction of Fishermens Way. It is also acknowledged that the City of Vaughan has contemplated "enhanced streetscaping" as part of the Master Plan and the ultimate condition of

Fishermens Way. We request that the City of Vaughan identify the level of obligation that the landowner is required to fulfil as part of proposed streetscape enhancements along Fishermens Way. Should the landowner be required to implement enhanced streetscape conditions for Fishermens Way as part of the fulfilment of application conditions, it is our request that the improvements be considered as Section 37 contributions.

It is acknowledged that the Vaughan Mills Centre Secondary Plan and Public Realm and Streetscape Master Plan are "living documents", and that review and update of the Plans is appropriate under the *Planning Act*, however, the Master Plan should acknowledge the planning process and approvals, and the conditions that were discussed and approved by the City and the landowner, as they relate to the Secondary Plan Area and the Plan's ultimate public realm and streetscape conditions.

We reserve the right to provide further comments as part of the ongoing Vaughan Mills Centre Public Realm and Streetscape Master Plan and any future update to the Vaughan Mills Centre Secondary Plan. We request that this letter be added to the public record for the City Council Meeting on November 16, 2021 and request to be notified of any future reports and/or meetings and decisions regarding this matter.

Weston Consulting is the planning consultant for H & L Title Inc. / Ledbury Investments Ltd., 2811187 Ontario Limited, and Anland Developments Inc., which comprise the Vaughan Mills Centre Secondary Plan Landowners Group (the "Landowners Group") who have land holdings located southeast of the intersection of Weston Road and Rutherford Road on the west side of the Vaughan Mills Centre Secondary Plan ("VMCSP") area in the City of Vaughan (herein referred to as the "subject lands").

We have reviewed the final Vaughan Mills Centre Public Realm and Streetscape Master Plan (the "Master Plan") and are pleased to provide the enclosed comments on behalf of the Landowners Group.

The subject lands are located south of Rutherford Road, west of Highway 400, east of Weston Road, and north of the future extension of Bass Pro Mills Drive. An air photo is included as Attachment 1 to this letter. The subject lands are currently zoned "*A* - *Agricultural*" by Vaughan Zoning By-law 1-88. However, the lands form part of the VMCSP, which was approved by York Region Council on June 26, 2014 and subsequently appealed by the Landowners Group, among others, to the Local Planning Appeal Tribunal (continued as the Ontario Land Tribunal, "OLT"). The VMCSP proposes to designate the subject lands within the "Vaughan Mills Centre Business District" for Prestige Office Employment and Prestige Employment uses. The Landowners Group had brought forward an alternative concept for the subject lands, which considered an alternative road network and an alternative alignment for the Black Creek corridor among other considerations such as permitted land uses, heights, and densities.

Phase 1 of the OLT proceedings associated with the appeals of the VMCSP by the Landowners Group was heard in June 2021, together with related appeals by the Landowners Group of the Vaughan Official Plan (2010). A decision on Phase 1 has occurred; however, Phase 2 of the OLT proceedings has yet to be heard and will address more detailed elements of the west side of the VMCSP, including permitted land uses, heights, densities, public road network, and the location of the realigned Black Creek and associated greenway corridor among other detailed

considerations. As such, the road network, Black Creek corridor alignment, and ultimate land uses have not yet been finalized for the west side of the VMCSP.

Based on our review of the final Master Plan, streetscape and public realm considerations have been identified for the west side of the VMCSP based on the unapproved road network and Black Creek corridor alignment. Section 2.9 of the Master Plan identifies that the public realm and streetscape design objectives described by the Plan are based on the Character Areas defined by the VMCSP. Figure 37 of the Master Plan identifies the Weston Street Corridor to have a commercial mixed-use focus, while the Business District is identified as a unique, mixed-use employment district that is centered around the Black Creek, which is intended to be a central stormwater management feature and public realm focal point. However, as previously noted, the land use permissions, road network, and Black Creek corridor are still being determined for the west side which may result in changes to the defined character for the subject lands. These undetermined features are key elements that influence character, shape the public realm, and define streetscape patterns. As such, it is premature to define public realm and streetscape guidelines based on considerations of land use and character that are potentially subject to change. These comments were raised in various stakeholder sessions with the project team.

The Master Plan, which is intended to build on the VMCSP, fails to adequately acknowledge the active appeals to the west side of the Secondary Plan and provides no discussion on how the guidelines would be applied in the event that the character, street patterns and central Black Creek focal point were to differ from what has been defined in the appealed VMCSP and the Master Plan document itself. To the extent that the land uses, densities, road network and Black Creek alignment may change from what was originally contemplated, it is premature to define public realm and streetscape design for the west side of the VMCSP at this time without a degree of certainty on these key defining elements.

Given the active OLT proceedings and the potential for changes to key public realm-defining elements on the west side of the VMCSP, we request that the approval of the Master Plan be deferred in its application to the west side of the Secondary Plan Area, including our client's lands, until these matters have been resolved at the OLT.

We write this letter on behalf of Limestone Gallery Investments Inc. ("Limestone") and Starburst Developments Inc. ("Starburst") owners of the lands located at 3255 Rutherford Rd, and 9070 Jane Street and 3191 Rutherford Road, respectively, in the Vaughan Mills Centre Secondary Plan Area (the "lands"). Limestone and Starburst have actively been participating in the Vaughan Mills Centre Public Realm Strategy and Streetscape Master Plan Study.

We have also provided correspondence to Urban Design staff with respect to our comments and issues during this process after each of the Public Information Sessions.

We were pleased to hear Council's direction for Staff to continue working with the stakeholders to have our issues addressed. Staff agreed to remove the portion of the Greenway that falls within the Limestone parcel as this portion of the proposed Greenway is not consistent with the approved Vaughan Mills Centre Secondary Plan. We are attaching our email correspondence- as supporting documentation for the removal of this section of the proposed Greenway.

We understood that the Figures could not be amended in advance of the Committee of the Whole meeting on November 3, 2021 due to timing. However, we are unsure as of this date whether the Final Report presently before Council for approval at its November 16, 2021 meeting, reflects the updated Figures to reflect the agreed upon -modification to delete the proposed Greenway from the Limestone parcel.

We respectfully request that Council amend the recommendation to approve the Vaughan Mills Public Realm and Streetscape Master Plan to include language that is reflective of the modifications as agreed by Staff, to be consistent with the approved Vaughan Mills Centre Secondary Plan.

Thank you for agreeing to removing the Greenway from the Limestone parcel. I trust this will be noted at today's meeting and subsequent Committee and Council meetings.

With respect to the pedestrian/cycling connection, we would argue the same, that a linkage is not contemplated in neither the Secondary Plan nor the Vaughan Pedestrian and Bicycle Master Plan. On Schedule H of the Secondary Plan there is a "Dedicated On-Street Cycling" path shown connecting Rutherford Rd to Fisherman's Way and the proposed Green Buffer Area along the 400 via Sweet River Blvd. This is an appropriate and safe connection for pedestrians/cyclists coming from Rutherford Road as it is farther from the HWY 400 off ramp.

Providing a pedestrian link along this same pathway would probably make the most sense, since there are already cross-sections in the VMCSP Public Realm Study that provide multi-use paths along this route. Thanks,
