I moved to this area to raise my family in what I thought and expected to be a quiet and spaced neighbourhood, made of single family dwellings with wide lots and safe from traffic. I paid a premium to live in this community and continue to pay a premium in taxes. While the city of Toronto keeps its taxes and mill rate low for its residents while enjoying the benefit of more amenities, Vaughan residents pay a premium for the benefit of living in less congested neighbourhoods. I am looking for your support to represent the residents of Weston Downs and Vaughan, do what the residents of Vaughan voted you in office for and therefore you **MUST REJECT THE APPLICATION FOR A 7 STOREY CONDO IN WESTON DOWNS THAT NONE OF THE RESIDENTS WANT NOR APPROVE.** We have been facing traffic congestion with cars cutting in through Weston Downs to bypass traffic on the main arteries. For years now, our main arteries and within Weston Downs have been congested and nothing has been done.
