EXTRACT FROM COUNCIL MEETING MINUTES OF FEBRUARY 15, 2022

Item 8, Report No. 4, of the Committee of the Whole, which was adopted without amendment by the Council of the City of Vaughan on February 15, 2022.

8. ROAD CLOSURE – PART OF RIDGEFIELD CRESCENT

The Committee of the Whole recommends:

- 1) That the recommendations contained in the report of the Deputy City Manager, Legal and Administrative Services & City Solicitor dated February 2, 2022, be approved;**
- 2) That the following be approved in accordance with Communication C2, Memorandum from the Deputy City Manager, Legal and Administrative Services & City Solicitor dated February 1, 2022:**

That recommendation 1. in the Report of the Deputy City Manager, Legal and Administrative Services & City Solicitor be deleted and replaced with the following:

- 1. That portions of Ridgefield Crescent located south of Rutherford Road to McNaughton Road, legally described as Part of Ridgefield Crescent on Plan 65M-2406, designated as Parts 8 and 9 on Reference Plan 65R-39429 (the “Lands”), as shown on Attachment #1, be approved to be stopped up and closed; and**
- 3) That Communication C4 from Carrie Gordon, Associate, External Liaison, Bell Canada, Bayfield Street, Barrie dated February 2, 2022, be received.**

Recommendations

- 1. That portions of Ridgefield Crescent located from south of Rutherford Road to McNaughton Road legally described as a portion of Block 264 on Plan 65M-2406, described as Parts 4, 6 and 7 on 65R-39429 and a portion of Ridgefield Crescent on Plan 65M-2406, described as Parts 8 and 9 on 65R-39429 (the “Lands”), as shown on Attachment #1, be approved to be stopped up and closed; and,**

ACTION: DECISION

Purpose

To enact a By-law to Stop up and Close the portion of Ridgefield Crescent located from south of Rutherford Road to McNaughton Road (the “Lands”), as shown on Attachment #1, in accordance with subsection 34 of the *Municipal Act, 2001*.

Report Highlights

Pursuant to the City’s Disposal of Property By-law #121-95, the Lands (Attachment #1) were declared surplus on December 10, 2021

At its meeting of December 10, 2021, Council directed staff to commence procedures as required by the *Municipal Act, 2001* to stop up and close the Lands.

The notice of Road Closure was advertised for two (2) consecutive weeks on the Disruptions and Closures page of the City’s website and the appropriate agencies have been notified of the proposed by-law.

Recommendations

1. That portions of Ridgefield Crescent located from south of Rutherford Road to McNaughton Road legally described as a portion of Block 264 on Plan 65M-2406, described as Parts 4, 6 and 7 on 65R-39429 and a portion of Ridgefield Crescent on Plan 65M-2406, described as Parts 8 and 9 on 65R-39429 (the “Lands”), as shown on Attachment #1, be approved to be stopped up and closed; and,
2. That Council enact a By-law to Stop Up and Close the Lands.

Background

Since 2016, City staff and Metrolinx have been collaborating on the planning, design and construction improvements on the Metrolinx's Regional Express Rail (RER) project within City of Vaughan's geographic jurisdiction.

On June 19, 2018, Council authorized the sale of sixteen fee simple interests and three temporary easements (up to December 31, 2025) for various City-owned parcels of land to Metrolinx for the completion of the Barrie Corridor RER Project.

On December 10, 2021, Council declared the Lands as surplus for the City's needs and requirements, authorized the sale of the Lands to Metrolinx, which included multiple temporary working easements to facilitate the construction of new noise attenuation fences, and directed staff to commence procedures as required by the *Municipal Act, 2001* to stop up and close the Lands as public highway.

The notice of Road Closure was advertised for two (2) consecutive weeks on the Disruptions and Closures page of the City's website and the appropriate agencies have been notified of the proposed by-law.
